Autogrill: trasferite le attività travel retail di HMSHost in Nord America a WDF

Milano, 6 settembre 2013 – Autogrill S.p.A. (Milano: AGL IM) e WDF S.p.A. rendono noto che in data odierna è stato effettuato il primo closing dell'acquisizione, da parte del gruppo WDFG SAU, delle attività travel retail di HMSHost in Nord America per le quali sono state ottenute dai concedenti le autorizzazioni al trasferimento.

Il prezzo pattuito dalle parti per il primo closing è pertanto di 105 milioni di dollari, pari all'87,8% del prezzo complessivo di 120 milioni di dollari stabilito per il trasferimento del 100% delle concessioni retail finora gestite da HMSHost.

Eventuali successivi closing verranno effettuati una volta ottenute le necessarie autorizzazioni da parte dei concedenti.
